Subject: Re-Accreditation 1/4/15 to 31/3/18 - 3 Year Cycle

The EA Board has approved Dressage moving to a 3 year re-accreditation cycle. As a result there had to be some rule changes that have now been approved by the EA Board.

Here's what you need to do over the next 3 years to 31/3/18 to maintain your accreditation – these are compulsory requirements

Seminars - Please make sure that you get an attendance certificate as this will be required at re-accreditation time

- All Judges A to H must attend a seminar at their level during the 3 year period Note: H & F level judges may use either an H level or an E/F level seminar for this purpose
- Young Horse Judges -- must attend a YH seminar every 3 years (not new). You need to keep in the same cycle e.g. attended a YH seminar in 2014 then the next one is due by 2017
- P-E Judges must attend a P-E seminar every 3 years effective from 1/1/15

Workshops - Please make sure that you get an attendance certificate as this will be required at re-accreditation time

All judges A to H - must attend two (2) workshops during the 3 year period on an annual basis i.e. either a workshop or seminar each year

Official Judging

- All Judges A to F must judge at 6 Official events at their highest level e.g. If an Advanced judge then must just at least 6 Advanced competitions over 6 events – that's 2 a year (an event is the fixture that cover 1, 2 or more days)
- H level Judges must judge a 6 Participation/Restricted Club events this can include Eventing

Note - FEI Judges - The above judging is in relation to your EA accreditation and therefore judging to be carried out in Australia

Other Judging

All Judges A to F – must judge at 3 other events up to your highest level

Activity Points

Accrue 18 points over the 3 year period – Note these are over and above the above compulsory seminar, workshop and judging

There has been a change to the points accrued for attending additional workshops over and above the compulsory 2 workshops as follows:

Participate in or attend additional dressage workshops/seminars

> 2-5 hours duration 2 points > 5-8 hours duration 4 points More than 1 5 points Participate in EA-approved workshops with international judges of at least 4* 3 points
